

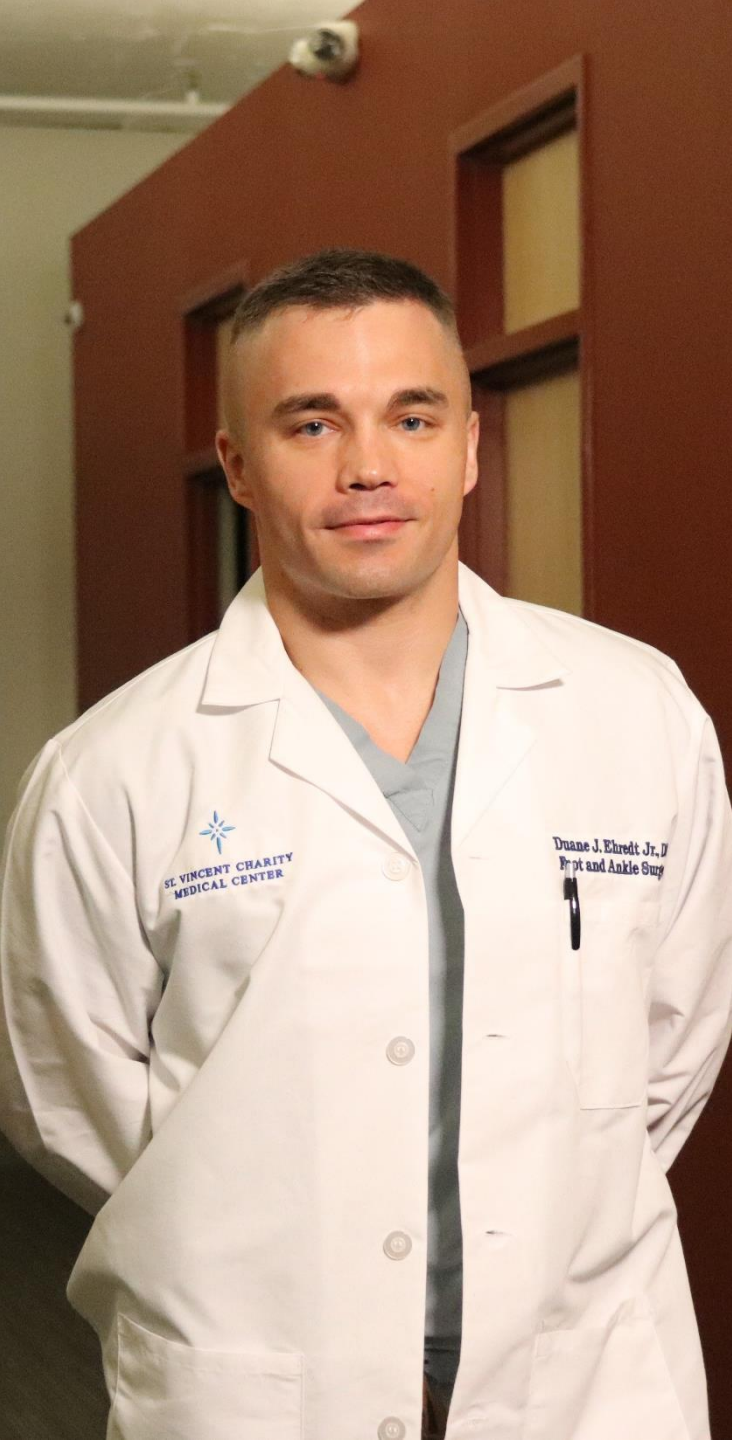

Insurance

- KSUCPM Students are required to have an maintain medical health coverage while enrolled at KSUCPM.
- To ensure compliance, KSUCPM students are automatically enrolled in and billed for the Student Accident and Sickness Insurance Plan.
- Payment is due in accordance with KSUCPM's tuition schedule.



Major Medical Insurance



- Network: Cigna (2019-2020 plan)
- In-network coverage is 80%
- Office Visit Co-Pay: \$20.00 (2019-2020 plan)
- Deductible: \$1,000 per year (2019-2020 plan)
- Full year coverage – August 1st – August 1st
- Available throughout the country.
- Dependents can be added at student's own cost of the plan.





Waive Insurance

- Students will have an opportunity to waive the insurance in September if they have proof of comparable insurance.
- All waiver information will be verified with your insurance company as part of the insurance verification process.
- Once your current insurance is verified and the waiver site has closed, KSUCPM will begin the process for reimbursement.



Your Plan must have the following in order to waive the insurance:

- My plan is provided by a company licensed to do business in the United States, with a U.S. claims payment office and a U.S. phone number.
- My plan is currently active and I agree to maintain health insurance coverage.
- My plan offers an unlimited coverage per accident or illness.
- My plan covers inpatient and outpatient medical care within the Cleveland, OH area (Emergency only coverage does not satisfy this requirement).
- My plan covers inpatient and outpatient mental health care within the Cleveland, OH area (Emergency only coverage does not satisfy this requirement).
- The deductible on my insurance plan does not exceed \$2,500 per individual or \$5,000 for a family plan.
- My plan provides coverage for pre-existing conditions with no waiting period or limitations.
- My plan provides coverage for prescription drugs.





University Health & Counseling Services

- KSUCPM has partnered with University Health Services & Counseling Services at Case Western Reserve University (Case) for primary care for students at their Medical Clinic and Counseling
- Students are automatically enrolled & cannot waive
- It is not insurance.





Services

- Students are seen for infections, injuries, allergies, immunizations, routine women's exams, sexually transmitted infection screening, etc.
- Counseling Services (Walk in visits: Stress, anxiety, test anxiety, depression, eating disorders, etc.





Immunizations

- You will need to be current on your immunizations your entire time here as a student
- All your immunizations records will be sent to University Health Services.
- All students are required to have an online account with University Health Services so you have access to your immunizations.



Required Immunizations

Tdap (Tetanus, Diphtheria, Pertussis) One Tdap vaccine within the past 10 years. Td will not be accepted.

Measles, Mumps, Rubella (MMR)

- 2 doses if born on or after 01/01/1957. Minimum 4 weeks apart between Dose 1 and Dose 2.
- Positive Rubella titer required

OR

Positive Rubeola IgG Titer, Positive Rubella IgG Titer, and Positive Mumps IgG Titer

Hepatitis B

- 3 doses required. Dose 1 to Dose 2: minimum 4 weeks apart; Dose 2 to dose 3: minimum 8 weeks apart (and at least 16 weeks after first dose)
- Hep B sAb Titer

The Hepatitis B series can take up to five months to complete. Students are advised to begin this series upon admission to the program

Varicella

- 2 doses required. Minimum 4 weeks apart between Dose 1 to Dose 2

OR a Positive Varicella Zoster IgG Titer

Flu Shot

- Flu shots are mandatory every year the during the flu season for KSUCPM Students.
- A flu clinic day is scheduled every year for students to get a flu shot on campus during flu season by University Health Services.



Required Titters

What titers are required for KSUCPM Students?

- Hepatitis B
- Rubella
- *Varicella is required only if you do not have a record of 2 doses required with the doses being 4 weeks apart*

What are titers?

Titer tests (blood tests) are used to determine a person's immune status to certain diseases and bacteria by screening for various types of antibodies. The results of these tests will **determine if they are currently immune or require vaccination.**

Once a student receives their titers are they compliant?

NO. Titers must be positive. As stated above the titer shows if a person's immune status to a certain diseases or they will require a vaccination.





Required TB Skin Testing

Tuberculosis screening (PPD)

- 1st year Students are required to have **TB Skin tests** (in the United States) done **twice** when they start here to be compliant on your TB test unless they have tested positive in the past for TB.
- Free TB Testing is scheduled for students twice in the month of August on campus by University Health Services.





Required TB Testing for those who have tested positive in the past

- A student who has a TB skin test that is evaluated as 'positive', will need to contact the University Health Services Doctor for instructions. Students may need get one or more of the following in order to be compliant.
 1. By having a blood test, Interferon Gamma Release Assay (Quantiferon-TB Gold In-Tube or T-Spot), performed less than 3 months starting class.
 2. An IGRA is required for those with past BCG vaccine who has tested positive with a PPD, unless they have a positive IGRA in the past
 3. A chest x-ray is required for the positive TB testing (PPD or IGRA)
 4. Provide copies of reports for chest-x-rays, blood tests, TB treatment statement, and PPD results.
