Bloomsburg University is a comprehensive public institution in northeastern Pennsylvania serving roughly 8000 undergraduate students and 660 graduate students. It offers 56 undergraduate programs and more than 58 minors along with 20 graduate programs, including doctorates in audiology and nursing practice. The College of Liberal Arts comprises thirteen departments and offers seventeen programs in the humanities, arts, and social sciences. Accreditations include CSWE, NAST, NASM, and NASAD.

Dean's duties include supporting and promoting all aspects of teaching and scholarly activity in the College; supervision of more than 150 faculty and staff; resolution of faculty, staff, and student issues; oversight of scheduling, strategic planning, program review; annual evaluation of temporary and tenure-track faculty; promotion and tenure review; oversight of Center for Visual and Performing Arts, Center for Community Research and Consulting, and Institute for Culture and Society, including Digital Humanities initiative; course scheduling and enrollment management; direction of faculty search processes; development of external funding for program

support; oversight of relevant accreditation processes; and administration of college budgets in excess of \$24,000,000.

Interim Dean, Zeigler College of Business, Bloomsburg University, 2018

The Zeigler College of Business was added to my portfolio for a six-month period. During this time, in addition to supervisory duties, I implemented new processes for assigning resources to faculty and student professional development and curricular enhancement. Other key college initiatives during this period included the Husky Dog Pound, a *Shark Tank*-like competition for high school and college students, AACSB reaccreditation efforts, engagement with the ZCOB Alumni Advisory Board and stewardship of substantial gifts, creation of the Professional Sales Lab, and new programs and opportunities in International Business, including an articulation agreement with the Community College of Philadelphia.

Associate Provost and Dean of Arts and Sciences and tenured professor of English, Mansfield University, 2009-2011

Mansfield University is a comprehensive public institution in Pennsylvania's northern tier serving roughly 2000 students. It offers five associate degree programs, 31 baccalaureate programs, four graduate programs, and 47 minors. The Arts and Sciences portfolio included twelve departments, including two academic support units, academic advising, and counseling. It offered one associate degree program and 20 baccalaureate programs.

Associate provost and dean's duties included membership in President's cabinet; faculty supervision including performance evaluations and leave approval; oversight of faculty search processes; budget planning and allocation; review and resolution of faculty and student complaints; management of enrollments, faculty assignments and course schedules, including summer schedules; review of departmental annual reports and five year program reviews; review of affiliation agreements; hearing of appeals for academic dismissal; representation of Provost as requested in his absence. Key initiatives included major budget realignments, revision of general education curriculum, and a successful application for membership in the Council of Public Liberal Arts Colleges.

Duties included conflict resolution, internship approvals, supervising search and screen activities in support of diversity, equity, and inclusion, interviewing faculty candidates, negotiating starting salaries for new hires, chairing Grants Resource Council, meeting with external reviewers during accreditation reviews (CSWE, NASAD, NAST, NASM), and supporting faculty research, travel and special initiative awards. I also drafted annual evaluations for probationary and temporary faculty and represented the college in construction and renovation meetings, Graduate Council, and other campus-wide bodies. FUNDRAISING HIGHLIGHTS AT BLOOMSBURG UNIVERSITY

Diehl Center for Law School Preparation: \$1.5 million gift from alumnus Craig A. Diehl, Esquire, CPA to establish a resource for students in all colleges and majors at Bloomsburg University who are considering law school, as well as faculty who may advise interested students.

Media & Journalism: \$100,000 gift (to date) to support experiential learning opportunities for current students through an in-house video production company that features documentary and long-form video projects.

Rehabilitative Justice Certificate Program: \$120,000+ received (to date) from the PA Department of Corrections to support program delivery and data collection at two regional State Correctional Institutions.

Anchor Program: \$2.2 million gift from the estate of Mitzi Marie Bryfogle to support programming for youth from the Pennsylvania foster care system. The Anchor Program gives children in the foster care system, ages 15-18, a chance to explore their academic interests and talents through a multi-year summer residential college life experience program and year-round mentorship opportunities.

Confer Radio Talent Institute: \$775,000 in gifts (to date) to establish and support an annual 9-day summer institute for students wishing to pursue careers in broadcasting. The institute features industry professionals from up and down the East Coast, rigorous classroom experience and a trip to Philadelphia to visit the Citizen's Bank Center to learn about the Phillies' and Flyers' sports broadcast teams. Participants earn certification by the Radio Advertising Bureau.
