Program is attracting students who were going to pursue a medical degree and have taken the MCATS but not the GRE. The program feels these students are prepared for the graduate program at the 50 th percentile of the MCAT. There was discussion on the minimum GRE score being accepted in the proposal. E. Glickman gave the rational for the minimum requirement. N. Barbour suggested that the 1000 minimum be removed from the proposal and use the 50 th percentile for either test.
