Dr. Mukherjee Named Editor-in-Chief of London-Based Journal





Deepraj Mukherjee, Associate Professor of Economics in the College of Business Administration at Kent State University at Stark, has been named Editor-in-Chief of the International Journal of Business and Economic Development (IJBED) as of August, 2017.

IJBED is a scholarly and refereed journal that provides information on economics and business for academics, policy makers, and professionals. Currently published four times annually, the journal's readership and authorship is broadly global from both developed and developing countries.

Dr. Mukherjee's research focuses on international trade and business, and he is a recognized scholar in emerging markets and economies. Mukherjee is also an affiliate member by invitation of the Emerging Market Internationalization Research Group (EMIRG) at the University of Sydney, Australia. This internationally-recognized group is tasked with studying the economic development of several emerging markets around the world.

Grant-Writing Advice from Director of Grants at a Research Foundation

Having reviewed thousands of research proposals over the years, Ingrid Eisenstadter, Director of Grants for the New York-based Eppley Foundation that supports scientific research, advises researchers seeking grants to start and finish early, seek feedback, include the details, and illustrate well. Some of her advice may surprise you. For example, if you submit your proprosal early and the foundation staff has time to review it before the avalanche of proposals that arrive on the deadline date, you may get a call to revise your proposal in a way that makes it more competitive and fundable. Class Preparation

Kent State Stark first-year students spend significantly less time preparing for class on average than students at comparison groupings of colleges. Kent State Stark first years spend nearly 11 hours per week on average preparing for class compared to slightly more than 13 and 14 hours at comparison institutions. Seniors spend nearly 3 hours more per week than their first-year counterparts preparing for class at Kent State Stark and a similar amount of time to students at comparison institutions.

Working for Pay Off Campus

Kent State Stark first-year students spend significantly more time working for pay off campus on average than students at comparison institutions. First years at Kent State Stark worked off campus nearly 18 hours per week on average compared to 10 to 12 hours at comparison institutions. Senior Students work nearly 20 hours per week on average off campus, which is similar to students at comparison institutions, ranging from 17 to 20%.


Although Kent State Stark students work more hours on average than other students at comparison institutions, not all do. One out of five Kent State Stark first-year and senior students do not work for pay off campus and another 19% of first years and 11% of seniors work between 1 and 15 hours per week off campus. At the other end of the work spectrum, 17% of first years and 31% of seniors at Kent State Stark work more than 30 hours per week on average.


Providing Care for Dependents


The average number of hours that Kent State Stark students and students at all 3 comparison institution groupings care for dependents is higher for seniors than first years, but is significantly lower for Kent State Stark seniors than seniors at all three comparison institutions.

(Data are included in Table 2 below the pie charts; shares taken from the "%" columns.)









NSF News

NSF Directorate for Biological Sciences Switching to No-Deadline

The National Science Foundation's <u>Directorate for Biological Sciences</u> will implement a "no-deadline" full proposal policy effective in 2018. There will be no call for preliminary proposals in January 2018. This new mechanism for receiving and reviewing proposals will cover core programs in the Division of Environmental Biology (DEB), the Division of Integrative Organismal Systems (IOS), the Division of Molecular and Cellular Biosciences (MCB), and the programs in the Research Resource Cluster of the Division of Biological Infrastructure (DBI).

NSF Major Research Instrumentation (MRI) Program – Limited Submission Instructions

The National Science Foundation's Major Research Instrumentation Program (MRI) serves to increase access to shared scientific and engineering instruments for research and research training. The program provides organizations with opportunities to acquire major instrumentation that supports the research and training goals of the organization and that may be used by other researchers regionally or nationally. Requests may be in the range of \$100,000 to \$4 Million. The deadline for proposals to the NSF MRI program is January 10, 2018, and the full set of guidelines may be found at: https://www.nsf.gov/publications/pub_summ.jsp?WT.z pims id=5260&ods key=nsf15504

There is an organizational limit of two MRI acquisition proposals and one MRI development proposal per organization.

Due to organizational limitation, Sponsored Programs is requiring a submission of letter of interest by FRIDAY, NOVEMBER 17, 2017. Please forward your letter of interest to my attention: Diana Skok at dskok@kent.edu. Your letter of interest must include: a cover page, 2-3 page narrative and abbreviated biosketch of PI. development proposal. If Sponsored Programs receives more than two letters of interest to submit an acquisition proposal, or more than one letter of interest to submit a development proposal, an internal review will be conducted. This program does require cost-sharing of 30% total project cost. Equipment purchases through the NSF MRI program may be eligible to receive cost share matching funds through the Ohio Action Fund. Revised NSF Proposal & Award Policies & Procedures Guide (PAPPG) – Effective January 29

The revised version of the NSF <u>Proposal & Award Policies & Procedures Guide</u> (PAPPG), (NSF 18-1) has been issued. The new PAPPG will be effective for **proposals submitted**, or due, on or after January 29, 2018. Significant changes include:

- Addition of a new eligibility subcategory on international branch campuses of U.S. Institutions of Higher Education;
- Revision of eligibility standards for foreign organizations;
- Implementation of the standard Collaborators and Other Affiliations (COA) template that has been in pilot phase since Apr.;
- Increase in the Budget Justification page limitation from three pages to five pages;
- Restructuring of coverage on grantee notifications to and requests for approval from NSF, including referral to the <u>Prior Approval Matrix</u> available on the NSF website; and
- Numerous clarifications and other changes throughout the document.

A webinar to brief the community on the new PAPPG will be held on **December 8 at 2 PM EST**. Sign up to be notified when registration is available on the <u>outreach notifications website</u>, by selecting "All NSF Grants and Policy Outreach Events & Notifications."

While this version of the PAPPG becomes effective on January 29, 2018, in the interim, the guidelines contained in the current PAPPG (NSF 17-1) continue to apply. We will ensure that the current version of the PAPPG remains on the NSF website, with a notation to proposers that specifies when the new PAPPG (including a link to the new Guide) will become effective. Grant Activity by Quarter, Fiscal Years 2016 – 2018

Table 1 displays grant submissions by quarter and outcomes and award rates for the corresponding quarterly grant submissions. Through late October 2017, Kent State Stark faculty, staff, and administrators submitted 59 grant proposals valued at \$5 million for FY 2017. A record number 29 grants valued at \$1.1 million have been awarded to date; the dollar value is the second highest in a fiscal year. During the first quarter of FY 2018, 8 grant proposals were submitted valued at \$0.52 million, and to date, three have been awarded valued at \$2,550. Through the first month of the second quarter of FY 2018, 12 grants have been submitted valued at \$0.23 million, and 1 has been awarded to date, valued at \$2,040. Nineteen grant submissions valued at \$0.81 million submitted during FY 2017 and 2018 are pending.
