Grants Awarded to Dr. Larison

Supporting "Guitar Weekend"



The Arts Midwest Touring Fund and the ArtSTART Program of the Ohio Arts Council has awarded grants to Dr. Adam Larison for the third annual "Kent State Stark Guitar Weekend." Ohio Arts Council has funded *Guitar Weekend* each of its three years and Arts Midwest is a new source of financial support for the program. During its initial two years, Guitar Weekend also benefited from the support of ArtsinStark.

Deepening the impact of the guitar on the broader community has been the main goal of the three-day festival, which is meant to be both educational and diverse in terms of styles. The event combines master class workshops and concert performances from world-renowned classical and jazz luminaries, performances from the Canton Guitar Society Youth Guitar Ensemble and the McKinley High School Guitar ensemble, and participation from students from across Stark County. Last year's *Guitar Weekend* closed with a two-hour performance by renowned French classical guitarist Judicael Perroy at Kent State Stark's Main Hall Auditorium, and included master classes and performances across Stark County by Nir Felder, Mickey Jones, and Stephen Lochbaum.

Kent State Stark Grant Activity Update

Grant Activity by Quarter, Fiscal Years 2017 – 2019

Table 1 displays grant submissions by quarter and outcomes and award rates for the corresponding quarterly grant submissions. The Stark Campus closed out fiscal year (FY) 2018 with 61 submissions valued at \$1.6 million, compared to 62 submissions in FY 2017 valued at \$5 million. We will not close out notifications until we are notified of all grants submitted in FY 2018 (in November 2018).

In FY 2018, 36 grants have been awarded to date, valued at \$428 thousand with 3 grants outstanding valued at \$215 thousand, which compares to 33 awards valued at \$1.1 million in FY 2017. Kent State Stark currently has a 62% award rate based on the number of proposals for FY 2018 and a 32% award rate based on the dollar value, compared to 53% and 23%, respectively, in FY 2017.

In the first month of FY 2019, one grant valued at \$100,000 has been submitted to date.
