	receive any undergraduate scholarships which they may have received from
	KSU. Every applicant with an exceptionally strong record is considered for a
	CWRU School of Law scholarship.

Graduation Requirements

Requirements to graduate with the BS degree program: To graduate, students must have minimum 120 credit hours, 39 upper-division credit hours of coursework, a minimum 2.500 major GPA and minimum 2.500 cumulative GPA. Students are required to participate in a study away opportunity. Students must have a minimum 2.500 overall GPA to participate in this study away requirement. Students must also fulfill an approved experiential learning experience, a two-course diversity requirement (domestic and global), complete a writing intensive course with a minimum C (2.000) grade.
