## Professional Licensure Disclosures For Clinical Psychology at Kent State University

The Consumer Information Disclosures (CID) law which is part of Title 4, Department of Education; 34 CFR 668.43 and 34 CFR §600.9 requires any program that grants a degree used toward professional licensure to provide explicit disclosures as to whether the degree meets the educational requirements for licensure in every US state and territory.

The Clinical Science program in the Department of Psychological Sciences is designed to prepare students for licensure as a Clinical Psychologist in Ohio. Our program's curriculum is also likely to lead to licensure eligibility in many other states as well. If you intend to pursue licensure outside the State of Ohio, we advise you to contact the applicable state credentialing authority to familiarize yourself with its specific requirements and determine its eligibility criteria. There are some features of doctoral training in clinical psychology that make determining whether the degree meets the educational requirements for licensure in every US state and territory complex. For this reason, you may encounter some variability between clinical psychology doctoral programs in how they understand the licensure requirements for each state and whether their curriculum meets the educational requirements for licensure in each state. Sources of complexity include the fact that the accrediting body for Clinical Psychology is the American Psychological Association (APA). The doctoral program in Clinical Psychology at Kent State University is accredited by APA, and APA accreditation is recognized in all 50 states as providing required education for psychology license eligibility. However, in recent years the APA has been transitioning away from a curriculum defined by credit hours in favor of competency-based education. Although most states recognize graduating from an APA-accredited program to be sufficient evidence that the curriculum meets requirements for licensure, some state boards of psychology still list credit-hour requirements for specific topics. In addition to not being aligned with APA accreditation standards, some states may use metrics that can be hard to interpret, such as requirements for a specific number of guarter hours when most universities are on a semester schedule. Also, some state boards of psychology have specific requirements that are not typically covered in an APA-accredited curriculum, such as training in recognizing victims of human trafficking. However, education or training to meet specific requirements could be completed while enrolled in the program at Kent State University (e.g., electives, independent study), in which case the curriculum at Kent State University would meet the requirements for that state. Furthermore, like every APA-approved program in clinical psychology, our program does not lead to licensure immediately upon graduation. This is because, in addition to education requirements for the doctoral degree, many jurisdictions have licensure requirements beyond the curricular requirements. For example, Ohio and many other states require postdoctoral supervised experience (e.g., after graduation), passing a written licensing exam, and passing an oral licensing exam prior to becoming licensed as a clinical psychologist. Therefore, determining whether or not the program at Kent State University meets the curricular requirements for licensure can be complex for the minority of states that do not accept a Ph.D. from an APA-accredited program as sufficient to meet the educational requirement for licensure.

Nevertheless, the professional preparation you receive in our program will assist you in pursuing licensure in Clinical Psychology. During your enrollment in the program, we suggest you visit the website of The Association of State and Provincial Psychology Boards (ASPPB) at asppb.net, as they post licensure requirements for specific states. They intend to update the information annually. You should review the state educational requirements for licensure for the state or territory in which you

intend to pursue licensure to ensure that you complete any state-specific requirements while enrolled in the program or make plans to complete them following graduation (e.g., continuing education requirements). For more information on licensing requirements, including contact information for every state and territory licensing board, please see the Association of State Boards of Professional Psychology (ASBPP) webpage [asppb.net]. All admitted and enrolled students are provided a stateby-state determination of whether or not our curriculum meets the licensure requirements or whether our curriculum might need to be supplemented by additional educational experiences to meet the licensure requirements. All applicants and prospective applicants are encouraged to review the stateby-state determination below. Finally, please note that completing our program does not lead to licensure immediately upon graduation. This is because, in addition to education requirements for the doctoral degree, many jurisdictions have licensure requirements beyond the curricular requirements. For example, Ohio and many other states require postdoctoral supervised experience (e.g., after graduation), passing a written licensing exam, and passing an oral licensing exam prior to becoming licensed as a clinical psychologist. Still, the professional preparation you receive in our program will assist you in preparation for licensure as a Clinical Psychologist. Our most recent data indicate that 90% of our alumni who graduated between 2009 and 2017 are licensed. Our graduates who did not become licensed typically are in positions that do not require licensure (e.g., teaching faculty positions or research positions). We will do our best to assist you in your career planning.

In the state-by-state disclosure below, we have listed our determination regarding whether the program at Kent State University satisfies the *curricular* requirements for licensure in each state, along with the website of the State Professional Association or License Authority. Kent State University makes every effort to ensure state licensure or certification information is current; however, state requirements may change. If you are planning to pursue professional licensure or certification, it is strongly recommended that you contact the appropriate licensing entity in that state to seek information and guidance regarding licensure or certification requirements before beginning an academic program.

Our determination is "Unable to determine," because we would need additional information about an individual student's educational record to make the determination. California accepts accredited programs like Kent State University's program to meet educational degree requirements; but California also requires additional specific coursework or continuing education training prior to licensure. Specifically, CA licensure requires 10 hours of training in human sexuality, 7 hours of training in child abuse assessment, 15 hours in spousal/partner abuse, detection and intervention strategies, 10 hours in aging and long-term care, and 1 semester or 1 quarter term course in alcoholism/chemical dependency detection and treatment. Students wishing to become licensed in California are advised to work with the Kent State University program to tailor their electives to meet these additional training requirements. While Kent State University's clinical psychology program does not require this content per se, there are many electives at Kent State University and community training events in Ohio that are available for students to assist them in preparing for licensure in California.

Our determination is "Unable to determine," because we would need additional information about an individual student's educational record to make the determination. New York's required coursework includes at least three graduate semester hours or five graduate guarter hours in each of the following seven substantive content areas: biological basis of behavior; cognitive-affective basis of behavior; social basis of behavior; individual differences; psychometrics; history and systems of psychology; and research design, methodology, and statistics. Kent State University's program is aligned with the most up-to-date standards of APA accreditation which does not require coverage of these seven areas in separate courses. Kent State University covers these areas, sometimes by infusing coverage of content areas in multiple courses across the curriculum. We have successfully advocated for our alumni to be eligible for licensure in New York on this basis. Nevertheless, Kent State University program does not require a separate course for each of these content areas. New York does not specify that they accept APA accreditation without additional course review. Therefore, students intending to apply for licensure in New York are advised to work closely with Kent State University Director of Clinical Training to choose electives or independent study available at Kent State University that will meet New York's requirements.
