#### **Project Overview**

#### A. Project Description

The Kent State University Airport was established in 1917 and is located within the lite residential and commercial properties of Stow Ohio. This facility functions as an airport for local individuals/businesses as well as a training facility for KSU students. This project will provide the design for pavement reconstruction for the apron area. It is being funded through an FAA AIP Grant for Fiscal Year 2026. This design will provide the bid documents/bid event for construction that is anticipated to be funded by a separate FAA AIP Grant for Fiscal Year 2027. Construction is anticipated for summer 2027 or 2028 depending on the timing of grant award. While this specific project and contract will be through design and bid documents only, this selection process will also be the basis for the selection of construction administration services for the project.

This design shall conform to all applicable FAA requirements and codes. All investigative work must be scheduled with the owner and coordinated with airport operations. Any disruption of airport operations or services must be scheduled with the airport in advance to allow permit proper notifications to be issued.

Kent State is currently in the process of selecting an AE team that will further develop the ALP (Airport Layout Plan) into a master siteplan. The selected apron reconstruction AE team will need to coordinate with this overall masterplan with regards to grading and site layout. Although full services for the apron reconstruction will not take place until FAA grant approval late in 2026, this team needs to be at the table to help inform the master siteplan.

The AE shall be an experienced consultant with first-hand experience working with the FAA and developing airport site and facility designs. Relevant experience with site design and pavement design that meet FAA requirements and standards are critical.

#### B. Scope of Services

Kent State University is requesting submissions of qualifications for the complete design for apron pavement rehabilitation and reconstruction. The design must meet current FAA standards. This will be an AIP grant funded project that must comply with all FAA DBE participation and State of Ohio EDGE participation.

The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority, the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Disadvantaged Business Enterprise, Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute, FAA requirements and the Agreement. Please note: EDGE goal is stated as 5% per Kent State University requirements. FAA DBE project requirements are 11.1%

The base fee shall include the design study and all necessary testing measures including pavement samples and cores.

Refer to the *Ohio Facilities Construction Manual* for additional information about the type and extent of services required for each. A copy of the standard Agreement can be obtained at the OFCC website at <a href="https://ofcc.ohio.gov">https://ofcc.ohio.gov</a>.

During the construction period, full time site observation and administration is anticipated to meet FAA requirements and regulations.

The major scopes of services include Pavement Design services and it is critical to have an engineer experienced in FAA regulations and pavement design. - Demonstrated ability to meet Owner's programmed project vision, scope, budget, and schedule on previous projects.
- Previous experience compatible with the proposed project (e.g., type, size).
- Relevant past work of prospective firm's proposed consultants.
- Past performance of prospective firm and its proposed consultants.
- Qualifications and experience of individuals directly involved with the project.
- Proposer's previous experience (numbers of projects, sizes of projects) when working with its proposed consultants.
- Specification writing credentials and experience.
- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

Interested A/E firms are required to address how they will implement Building Information Modeling ("BIM") on the project, experience and level of training of staff related to BIM, incorporation of team partners that have previous BIM experience, and an understanding of collaborative BIM processes, including but not limited to the *State of Ohio BIM Protocol* available at the OFCC website at <a href="https://ofcc.ohio.gov">https://ofcc.ohio.gov</a>.

Interested A/E firms are required to submit the *Commitment to Participate in the EDGE Business Assistance Program* form in its Statement of Qualifications (Form F110-330) submitted in response to the RFQ, to indicate its intent to contract with and use EDGE-certified Business Enterprise(s), as a part of the A/E's team. The *Intent to Contract and to Perform* and / or waiver request letter and *Demonstration of Good Faith Effort* form(s) with complete documentation must be attached to the A/E's Technical Proposal.
