
Respondents and Their Engagement in the RPTM Field

- <u>Professional Organizations</u>: In the 2022 calendar year, **43**% (*n*=3) of respondents were members of professional organizations.
- <u>Professional Conferences</u>: In the 2022 calendar year, **14%** (*n*=1) of respondents attended a professional conference.
- <u>Volunteer Activities in RPTM and/or Inclusive Recreation</u>: In the 2022 calendar year, **71%** (*n*=5) of respondents indicated that they participated in volunteer activities in recreation, parks, tourism and/or inclusive recreation.
- Employment in RPTM during College Career: In response to "Over the course of your college career, how much of your paid employment was in the recreation, park, and tourism field?" In the 2022 calendar year, **86%** (n=6) of those that worked while in college indicated that most to all of their paid employment was within the recreation, park, and tourism field.
















