1. Summary

This report provides a statistical analysis of the Tuscarawas Campus enrollment for the Spring 13 Term. The Tuscarawas Campus experienced a 3.68% decrease in student headcount; 2,406 students in Spring 13 compared to 2,498 students in Spring 12 for a net decrease of 92 students. Undergraduate enrollment decreased by 3.68% (-92 students) and graduate enrollment increased by 0% (0 students).

Student FTE decrease by 9.52%; the Tuscarawas Campus generated 145.94 less FTE compared to Spring 12. Undergraduate FTE decreased by 9.52% (-145.94 FTE) and graduate FTE increased by 0% (0.00 FTE).

The undergraduate mean unit load (MUL) is 8.65 compared to 9.21 in Spring 12. Graduate MUL is 0.00 compared to last year's 0.00 and the campus MUL is 8.65 compared to 9.21 last year.
