



# Forever Buckeye Ohio Residency Application

Guideline C (5) of 3333-1-10 Ohio Student Residency for State Subsidy and Tuition Surcharge Purposes

The rules of the chancellor for determining student residency shall grant residency status to a person who, while a resident of Ohio for state subsidy and tuition surcharge purposes, graduated from a high school in this state or completed the final year of instruction at home as authorized under section 3321.04 of the Revised Code, if the person enrolls in an institution of higher education and establishes domicile in this state, regardless of the student's residence prior to that enrollment.

I understand that a reclassification of residency for-tuition-purposes could impact my bill and/or financial aid package.

The following documents must be submitted with this form: a) your Ohio high school transcript or a verification of your graduation on the high school's letterhead stationery; and b) your current housing lease, property deed, or notarized affidavit from parents/other. (Note: a copy of a high school diploma is not sufficient evidence of high school graduation. An Ohio high school does not include GED.) If you are not a U.S. citizen, you must attach copy of supporting documents establishing your current immigration or Visa status.
