## Teaching Experience

---

### **Law of Mass Communication (MDJ 40006)**

Taught a course that allows students to develop an understanding of how the law affects mass media and its practitioners; an ability to identify legal issues and to apply knowledge to specific situations likely to be confronted by working professionals; and an appreciation of the history and role that the First Amendment and other protections for free expression and press freedom play in a diverse American society. Students learn to identify the basic parameters of First Amendment protection, including key legal limitations on free speech and press freedom.

### **Argumentation & Persuasive Communication (COMM 35464)**

Revised and taught a course in which students are introduced to principles and practices of effective argumentation and persuasive communication. Through exposure to rhetorical and social scientific theories, students engage in research to develop argumentative cases and assess persuasive messaging strategies in mediated contexts. The course emphasizes processes of

reasoning, the nature and use of evidence, recognition of common fallacies, media/information literacy, and generation and construction of valid and ethical arguments.

### **Criticism of Public Discourse (COMM 26000), Kent State University**

Taught course centering on the critical examination of public speeches representing diverse perspectives on a range of historic and contemporary issues, with an emphasis on methods of evaluating public oral communication and understanding the role of speechmaking in social discourse. The course satisfies a Kent Core requirement as well as the University Diversity requirement.

### **Communication Grammar Review (COMM 21000), Kent State University**

Taught a five-week online course that runs three times a semester and twice in summer. The course enhances proficiency in English language grammar, punctuation, word usage, and style, and it is required for majors in the School of Communication Studies and the School of Journalism and Mass Communication. Students must pass the course with a grade of C or better.

### **Communication and Influence (COMM 45902), Kent State University**

Taught a Writing Intensive Course centered on key concepts and theories associated with persuasive communication. Students analyze and critique research regarding messages intended to influence people's attitudes and behaviors and apply course materials to the creation and implementation of their own persuasive campaigns.

### **Freedom of Speech (COMM 45007), Kent State University**

Taught course that allows students to develop an understanding of the socio-legal issues and responsibilities of speech as well as an awareness of specific issues and current controversies regarding freedom of speech in the United States and elsewhere. Students also learn about specific issues regarding local and regional free speech issues along with those issues specific to various organizations and institutions.

### **Foundations of Communication (COMM 20000), Kent State University**

Taught course that serves as an introduction to the communication studies major and its different concentrations. Students learn about the communication studies faculty, research, and courses offered within the school as well as possible careers in communication studies and involvement opportunities to supplement the curriculum. Students are required to complete the course within the first 20 credits in the major and earn a C or better in the course.

### **High Impact Professional Speaking (COMM 45807), Kent State University**

Taught course focusing on the development of professional speaking skills in a variety of professional style contexts. Students learned the principles and practices of effective verbal and nonverbal communication strategies, which were enhanced through multiple speaking opportunities. This course helped students fine-tune skills and was designed for students who sought to enhance their professionalism by improving public communication behaviors.

### **Public Communication in Society (COMM 26001), Kent State University**

Taught in-class and online sections of a course on communication in public situations, examining issues in media, politics, corporate communication, public opinion, and communication in

executive, legislative, and judicial settings. Students were given the opportunity to demonstrate their knowledge and form arguments about current media issues, relevant communication and media theories, the influence of political speech and campaigns, and the interplay between individuals, society, and institutions via mediated communication.

### **Business and Professional Communication (COMM 25863), Kent State University**

Taught course providing students with the relevant theory and practical skills necessary to communicate successfully in contemporary global business environments. This class focused on professional communication strategies, teamwork, verbal and nonverbal messages, listening skills, interviews, job search strategies, résumé and cover letter building, diversity awareness, interpersonal communication skills, information technology, and presentation skills.

### **Interviewing (COMM 35860), Kent State University**

Taught an applied course in which students learn about interviewing in employment, recruiting, information-gathering, survey, persuasive, therapeutic, and law enforcement contexts. The class not only presented basic information on interviewing structures and verbal/nonverbal communication techniques, but also required students to demonstrate their acquired skills by conducting interviews, responding as interviewees, and observing as peer evaluators.

### **Media Use and Effects (COMM 45006), Kent State University**

Taught in-class and online sections of a mass communication course tracing evolution of media theories, perspectives, and research on topics such as ethnicity and gender portrayals, media regulation, themes in entertainment, news, political campaign coverage, images of sex and violence, and the emergence of new media technologies. Also addressed the role of psychological and sociological variables that could impact audience members' use of media and the effects of media exposure.

### **Introduction to Human Communication (COMM 15000), Kent State University**

Taught stand-alone and lecture-lab sections, which included theories of public, small group, and interpersonal communication as well as strategies, principles, and ethics of informative and persuasive public speaking as well as group presentations. Supervised student interns in Personalized System of Instruction program.
